ORDER

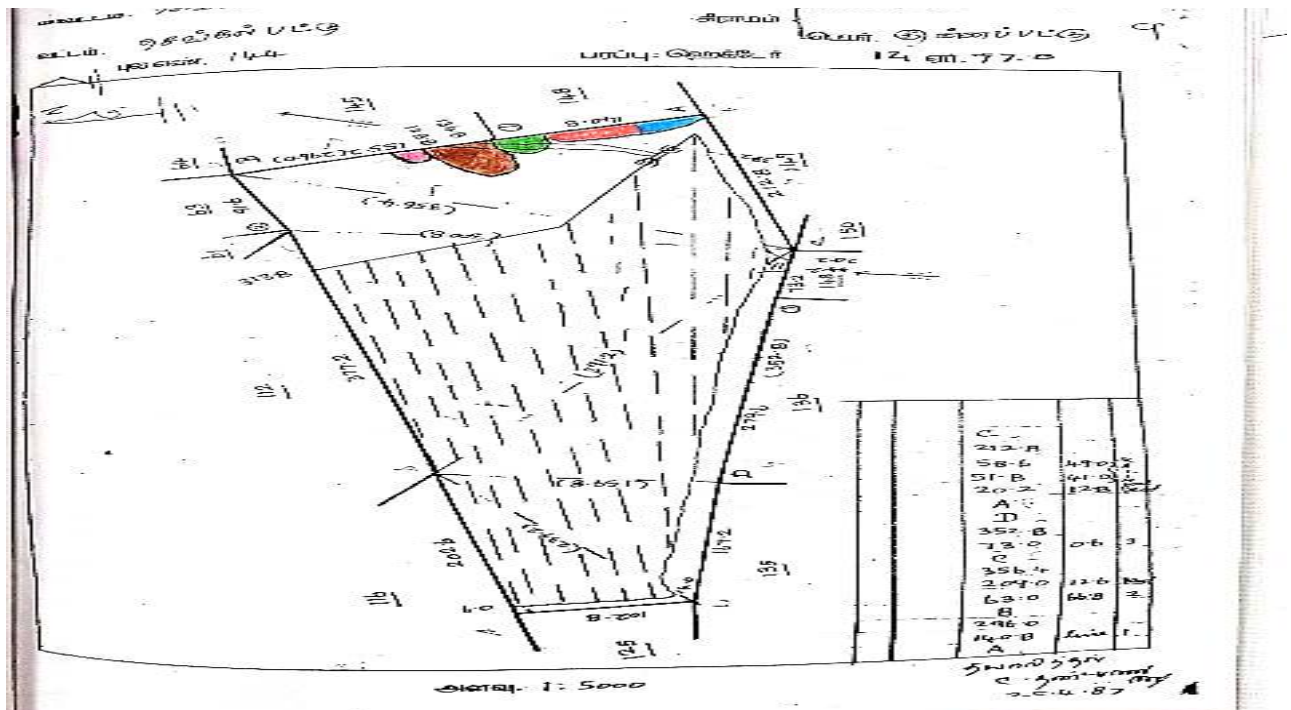

Mr.A.Selvendran, learned Special Government Pleader, appearing for the

respondent-Government, submits that the encroachments have been removed, which fact has been disputed by Mr.S.Parthasarathy, learned Senior Counsel, appearing for the petitioner. He further submits that there is an encroachment by the petitioner also and that he would remove the said encroachment and ensure that the Eri-Poramboke is restored.

2. Taking note of the submissions that there will be no encroachments in the marked portions in the Sketch at Page 9 of the Typed Set of Papers, which is scanned below, we make it clear that the said encroachments shall be removed, if not already done. The sketch reads as under :
