ORDER

This Criminal Original Petition has been filed to direct the 2nd respondent to file a final report in Crime No.902 of 2020 pending on the file of Inspector of Police, Tiruvannamalai Vettavalam, Police Station.

2. The learned counsel appearing for the petitioner submitted that though the respondent has registered a case in Crime No.902 of 2020, no final report has been filed till date. Hence, the present petition has been filed.
