2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Kuliyur Village Sri MakaliAmman Thirukovil" at Bharamadesam Post, Anthiyur Via, Erode District on 23.02.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 05.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
