ORDER

The Writ Petition has been filed to direct the respondent authority to direct the respondent to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of "E.Kattur Village Arulmigu Sree Sellandi Amman and Mariyamman Temple Festival" at Sangakiri Taluk, Salem District on 27.02.2023 between 6 PM to 11 PM based on the petitioner's representation dated 06.02.2023.
