ORDER

The Writ Petition has been filed to direct the respondent authority to direct the respondent to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of "Natrapalli Arulmigu Sree Periyandavar Temple Festival" at Natrapalli Taluk, Tirupathur District on 19.02.2023 between 6 PM to 11 PM based on the petitioner's representation dated 07.02.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police are hereby directed to consider the representation of the petitioner, dated 07.02.2023 and pass suitable orders based on the above said circular.
