ORDER

The Writ Petition has been filed to direct the first and second respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Pasupathi Amman Tample festival” Nachipatti Village, Vennandur Post, Rasipuram Taluk, Namakkal District on 10.03.2023 between 06.00 PM to 11.00 PM, by considering the petitioner's representation dated 06.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Pasupathi Amman Tample festival” Nachipatti Village, Vennandur Post, Rasipuram Taluk, Namakkal District on 10.03.2023, the petitioner has sent a representation dated 06.02.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.
