Prayer:- Writ Petition filed under Article 226 of the Constitution of India, 1950, praying to issue a Writ of Mandamus, directing the Respondents to step up the pay of the Petitioner on par with his junior Vinoth Kumar with effect from 01.04.2017 when anomaly arose by taking into consideration the judgments of this Hon'ble Court in W.A. No. 78 of 2021 by its dated 09.04.2021 and W.A. No. 178 of 2021 order dated 18.03.2021 by considering the fact that transfer from one Panchayat Union to another would not disentitle the Petitioner for grant of stepping up of pay.

3. Having regard to the limited nature of relief sought, this Court without expressing any view on the correctness or entitlement of the claim made by the Petitioner, passes the following order:-

- (i) the concerned authority shall immediately examine the representations dated 21.04.2022, 04.06.2022 and 13.06.2022 made by the Petitioner including ascertaining as to whether the Petitioner would be entitled for the relief claimed;
- (ii) if it is found that any other details or supporting documents is necessary, the deficiencies in that regard shall be informed in writing to the Petitioner requiring the same to be furnished within a time frame of not less than 15 days for the same;
- (iii) in the event of not being satisfied with the requirements even thereafter, an enquiry shall be conducted affording full opportunity of personal hearing to the Petitioner and all other persons concerned to explain their position in that regard;
- (iv) a reasoned order shall be passed dealing with each of the contentions raised on merits and in accordance with law and the decision taken communicated by 31.08.2023 under written acknowledgment; and
- (v) the report of such compliance shall be filed before the Registrar (Judicial) of this Court.
