ORDER

The Writ Petition has been filed to direct the respondent authorities to direct the respondents to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of "Sri Devathi Amman Temple Festival" at Venkadathampatti Village, Venkadathampatti Post, Uthangarai Taluk, Krishnagiri District on 14.02.2023 between 6 PM to 11 PM based on the petitioner's representation dated 10.02.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police are hereby directed to consider the representation of the petitioner, dated 10.02.2023 and pass suitable orders based on the above said circular.
