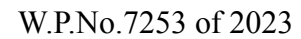

ORDER

(Order of the Court was made by The Hon'ble Acting Chief Justice)

Mr.P.Janarthanan, S/o.Pannerselvam, has filed this writ petition praying for issuance of writ of mandamus to the first respondent to consider his representation dated 09.01.2023 and remove the encroachment made by respondents 2 and 3 on the Bangalore - Madras National Highways.

2. The case of the petitioner is that he is the absolute owner of S.No.488/34 situated at M.B.T.Road, Arapakkam Village, Walajah Taluk, Ranipet and the land in S.Nos.488/35 and 488/36 belong to respondents 2 and 3. The first respondent acquired 0.0251 cents out of 0.0263 cents in S.F.No.488/35 and 0.0047 cents out of 0.0050 cents in S.F.No.488/36. The petitioner states that respondents 2 and 3 have laid a foundation pit in the prohibited area and thereby violated the Rules of NHAI in respect of the wayside construction by encroaching upon the land belonging to the National Highways. The learned counsel for the petitioner submits that the petitioner has sent a representation dated 09.01.2023 to the first respondent, which did
