The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct the Cultural programme (Adal Padal Nigalchi) in the event of Dharapuram, Jawahar Nagar Arulmigu Sree Kaliyamman Temple Festival at Dharapuram Taluk, Tiruppur District on 10.03.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 09.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Dharapuram, Jawahar Nagar Arulmigu Sree Kaliyamman Temple Festival at Dharapuram Taluk, Tiruppur District on 10.03.2023 between 6 PM to 11PM, the petitioner has sent a representation dated 09.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 09.02.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
