ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Selambagoundampalayam Village Arulmigu Sree Pottusamy Temple Festival at Modakurichi Taluk, Erode District on 05.03.2023 between 06.00 PM to 11.00 PM, by considering the petitioner's representation dated 08.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Selambagoundampalayam Village Arulmigu Sree Pottusamy Temple Festival at Modakurichi Taluk, Erode District on 05.03.2023, the petitioner has sent a representation dated 08.02.2023 to the respondent.
