ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural event i.e., Adal Padal (Song and Dance) in the event of Arulmigu Sri Kaliamman Temple, Raja Pattinam Village, Valapadi Taluk, Salem District on 10.03.2023 at 6.00 pm onwards, by considering the petitioner's representation dated 13.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Arulmigu Sri Kaliamman Temple, Raja Pattinam Village, Valapadi Taluk, Salem District on 10.03.2023, the petitioner has sent a representation dated 13.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 13.02.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
