## **ORDER**

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Chettichavadi, Manthoppu Arulmigu Sree Ooradi Mariyamman and Kaliyamman Temple Festival at Salem Taluk & District on 24.02.2023, between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 10.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Chettichavadi, Manthoppu Arulmigu Sree Ooradi Mariyamman and Kaliyamman Temple Festival at Salem Taluk & District on 24.02.2023, the petitioner has sent a representation, dated 10.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
