ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Aayakattur Village Arulmigu Sree Maha Mariyamman Temple Festival at Kumarapalayam Taluk, Namakkal District on 22.02.2023, between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 10.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Aayakattur Village Arulmigu Sree Maha Mariyamman Temple Festival at Kumarapalayam Taluk, Namakkal District on 22.02.2023, the petitioner has sent a representation, dated 10.02.2023 to the respondent Police.
