The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct the Cultural programme (Adal Padal Nigalchi) in the event of Nachipatti Village Arulmigu Sree Pasubathi Amman Temple Festival at Rasipuram Taluk, Namakkal District on 11.03.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 11.02.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 11.02.2023 and pass suitable orders based on the above said circular.
