ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Pamankaradu Arulmigu Sree Sembu Mariyamman Temple Festival at Omalur Taluk, Salem District on 23.02.2023, between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 10.02.2023.
