ORDER

The Writ Petition has been filed to direct the the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 07.03.2023 at 06.00 p.m to 11.00 p.m., at "Sri Periya Badrakaliamman & Sri Periya Mariamman Temple festival" Coolie line Village, Mettur Dam Post, Mettur Taluk, Salem District by consider and pass orders on the representation dated 11.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Periya Badrakaliamman & Sri Periya Mariamman Temple festival" Coolie line Village, Mettur Dam Post, Mettur Taluk, Salem District 07.03.2023 at 06.00 p.m to 11.00 p.m., the petitioner has sent a representation dated 11.02.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondents submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondents police is hereby directed to consider the representation of the petitioner, dated 11.02.2023 and pass suitable orders based on the above said circular.
