ORDER

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Kaliamman Temple Festival” Seevur Village, Seevur Post, Gudiyatham Taluk, Vellore District on 28.02.2023 at 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 11.02.2023 to the respondent police.
