## **ORDER**

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Parigam Village Arulmighu Sri Agni Mariamman Koil at Nallampallai Taluk, Dharmapuri District on 22.02.2023, between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 18.01.2023.
