ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sri Throwpathiamman Temple Festival, Eswaramurthipalayam Village, Eswaramurthipalayam Post, Rasipuram Taluk, Namakkal District on 28.02.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 13.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of M.Rasampalayam Village Arulmigu Sree Bhagavathi Amman Temple Festival at Mohanur Taluk, Namakkal District on 28.02.2023, the petitioner has sent a representation, dated 13.02.2023 to the respondent Police.
