ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Chettichavadi Arulmigu Sree Uradi Mariyamman & Uradi Kaliyamman Temple Festival at Salem Taluk & District on 26.02.2023 between 06.00 PM to 11.00 PM, by considering the petitioner's representation dated 13.02.2023.
