ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of M.Kuthampalayam Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District, on 08.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 13.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of M.Kuthampalayam Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District, on 08.03.2023, the petitioner has sent a representation, dated 13.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
