2.The prayer sought for in the present Writ Petition is to direct the second respondent to implement the recommendations of the third respondent dated 01.06.2017, passed in Na.Ka.503/2016(C).

3.Based on the petitioner's representation seeking for mutation of records and grant of separate patta, the third respondent, by Proceedings dated 01.06.2017, had made favourable recommendations to the second respondent herein before whom the proceedings are pending.
