ORDER

The Writ Petition has been filed to direct the respondent authority to direct the respondent to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Athandamaruthur Village Arulmigu Sree Angalamman Temple Festival at Thirukovilur Taluk, Kallakurichi District on 23.02.2023 between 6 PM to 11 PM based on the petitioner's representation dated 16.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Athandamaruthur Village Arulmigu Sree Angalamman Temple Festival at Thirukovilur Taluk, Kallakurichi District on 23.02.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 16.02.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 16.02.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
