permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Vanichampatti Village Arulmigu Sree Maha Sakthi Mariyamman Temple Festival at Omalur Taluk, Salem District on 28.02.2023, between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 16.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Vanichampatti Village Arulmigu Sree Maha Sakthi Mariyamman Temple Festival at Omalur Taluk, Salem District on 28.02.2023, the petitioner has sent a representation, dated 16.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
