ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Gudiyatham Town Sri Durgaiamman Koil at Lingundram, Gudiyatham Taluk, Nellorepettai, Vellore District on 05.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Gudiyatham Town Sri Durgaiamman Koil at Lingundram, Gudiyatham Taluk, Nellorepettai, Vellore District on 05.03.2023, the petitioner has sent a representation, dated 07.02.2023 to the respondent Police.
