ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Kuruppanaickanpalayam Village Arulmigu Sree Maha Mariyamman Temple Festival at Bhavani Taluk, Erode District on 04.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 15.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kuruppanaickanpalayam Village Arulmigu Sree Maha Mariyamman Temple Festival at Bhavani Taluk, Erode District on 04.03.2023, the petitioner has sent a representation, dated 15.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
