ORDER

The Writ Petition has been filed to direct the respondent to give permission to conduct Cultural programme (Adal Padal Nigalchi) in the event of Korathupatti, Sathiya Colony Arulmigu Sree Sakthi Kaliyamman Temple Festival at Salem Taluk & District on 02.03.2023 between 06.00 PM to 11.00 PM by considering the Petitioner's representation dated 17.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Korathupatti, Sathiya Colony Arulmigu Sree Sakthi Kaliyamman Temple Festival at Salem Taluk & District on 02.03.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 17.02.2023 to the respondent.
