The Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) at Salem District, Attur Taluk, Pazhaniyapuri Village, Sri Selliamman Thirukovil Festival on 26.02.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 07.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of at Sri Selliamman Thirukovil Festival, Attur Taluk, Pazhaniyapuri Village, Salem District, on 26.02.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 07.02.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 07.02.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
