ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Thukkiyampalayam Village Arulmigu Sree Kaliyamman Temple Festival at Valapadi Taluk, Salem District on 08.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 17.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Thukkiyampalayam Village Arulmigu Sree Kaliyamman Temple Festival at Valapadi Taluk, Salem District on 08.03.2023, the petitioner has sent a representation, dated 17.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
