ORDER

The learned counsel for both sides are present.

2.When the matter is taken up for hearing, the learned Additional Advocate General appearing for the respondents submitted that a writ petition has been filed in W.P.No.21590 of 2004 by the petitioner herein for the same relief, as prayed in the present writ petition, in the year 2004 and the same was dismissed by an order of this Court dated 30.11.2011, by observing as follows:

“9.In view of the fact that the petitioner has registered with the employment exchange and he belongs to the Scheduled Caste community, as and when his turn comes as per seniority in the employment exchange, his name shall be suitably recommended, the respondent department shall also consider the case of the petitioner appointment, if is otherwise eligible and suitable.”
