ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Maha Sakthi Mariamman Temple festival” Vellikuttai, Elanthakuttai Village, Kadachanallur Post, Tiruchengode Taluk, Namakkal District on 02.03.2023 at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 17.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Maha Sakthi Mariamman Temple festival” Vellikuttai, Elanthakuttai Village, Kadachanallur Post, Tiruchengode Taluk, Namakkal District, on 02.03.2023 the petitioner has sent a representation, dated 17.02.2023 to the respondent Police.
