The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Mandu Mariamman Temple Festival” Seengkeri Village, Mahendramangalam Post, Palacode Taluk, Dharmapuri District on 01.03.2023 at 06.00 PM to 11.00 PM, by considering the petitioner's representation dated 17.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mandu Mariamman Temple Festival” Seengkeri Village, Mahendramangalam Post, Palacode Taluk, Dharmapuri District on 01.03.2023 at 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 17.02.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 17.02.2023 and pass suitable orders based on the above said circular.
