ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Indhira Nagar Arulmighu Sri Muthumariamman Koil at Alankayam Road, Perumalpettai Post, Vaniyambadi, Thirupathur District on 03.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 18.01.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 18.01.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
