ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Veesanam Village Arulmighu Sri Maha Mariamman Koil Kumbabishegam at Veesanam Post, Namakkal Taluk and District on 03.03.2023 at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 16.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Veesanam Village Arulmighu Sri Maha Mariamman Koil Kumbabishegam at Veesanam Post, Namakkal Taluk and District on 03.03.2023, the petitioner has sent a representation, dated 16.12.2022 to the respondent Police. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 16.12.2022 and pass suitable orders based on the above said circular.
