ORDER

The prayer sought for herein is for a writ of mandamus directing the respondents to consider the representation dated 15.10.2022 to survey the agricultural land admeasuring an extent of 2.14 acres of agricultural lands bearing old Survey No.607 new survey no.607/3 of Karadanoor Village, Balethottam Revenue Village, Pochampalli Taluk, Krishnagiri District.

In order to survey the land of the petitioner at Old Survey No.607, New Survey No.607/3 situated at Karadanoor Village, Balethottam Revenue Village, Pochampalli Taluk, Krishnagiri District, the petitioner had given a representation-cum-application dated 15.10.2022 and on 27.09.2022 itself the petitioner had paid the necessary fee to that effect.
