4. Considering the distance between the petitioner's house and the Court, and also the fact that the petitioner is living with her three year old child. Accordingly, the present Tr.C.M.P. is allowed and the HMOP No.161 of 2022 pending on the file of the Subordinate Court, Udumalpet, is withdrawn and transferred to the file of the Subordinate court, Pollachi. Further, the Subordinate Court, Udumalpet, is directed to transfer the records in connection with HMOP No.161 of 2022, to the Subordinate court, Pollachi, within a period of two weeks from the date of receipt of a copy of this order.
