Heard Ms.Vindhya Vasini, learned counsel for the petitioner and Mrs.R.Anitha, learned Special Government Pleader, for respondents 1 and 2.

Learned Special Government Pleader for respondents 1 and 2, on instructions from the Tahsildar, Vandalur, submits that Survey No. 330/2 was inspected and it found that there is an encroachment in the way of one hut house and two cement sheet houses since more than five years. The enquiry notice would be served to the petitioner and the respondents to survey the field land. Then the notices under Section 7 and 6 of the Tamil Nadu Land Encroachment Act, 1905 would be served to the encroachers to remove the encroachment as per law.
