The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Mavalingai Village Arulmigu Sree Perumal Swamy Temple Festival at Veppanthattain Taluk, Perambalur District on 27.03.2023 between 06.00 PM to 11.00 PM, by considering the petitioner's representation dated 20.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Mavalingai Village Arulmigu Sree Perumal Swamy Temple Festival at Veppanthattain Taluk, Perambalur District on 27.03.2023 between 06.00 PM to 11.00 PM., the petitioner has sent a representation dated 20.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 20.02.2023 and pass suitable orders based on the above said circular.
