2. The limited prayer sought for in this Writ Petition is for a direction to the respondents herein, to dispose of the Review Petition preferred by the petitioner dated 13.06.2022, within a stipulated time.

3. It is needless to point out that whenever a Review Petition is preferred before the Revisional Authority, there is a duty cast on them

to dispose of the Review Petition expeditiously. Non-compliance of such a responsibility would amount to dereliction of duties and this Court would be justified in directing the authority to dispose of the Review Petition, within a stipulated time, in exercise of its powers under Article 226 of Constitution of India.

In the light of the above observations, there shall be a direction to the respondents herein, to dispose of the petitioner's Review Petition dated 13.06.2022, if not already disposed of, on its own merits and in accordance with law, within a period of three (3) months from the date of receipt of a copy of this order.

5. With the above direction, the Writ Petition stands ordered. No costs.
