ORDER

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Mariamman Temple festival" Umbilikamarammangalam Village, Umbilikamarammangalam Post, Omalur Taluk, Salem District on 09.03.2023, the petitioner has sent a representation dated 21.02.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.
