**ORDER**

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the

Festival at Nallampalli Taluk, Dharmapuri District on 07.03.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 20.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Chandiranallur Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Nallampalli Taluk, Dharmapuri District on 07.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 20.02.2023 to the respondent.
