PRAYER : Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of mandamus to forbear the respondents from interfering with the running of the petitioner's pushcart at MTH Road by side of Saravana Store main gate, opp. To Lukas TVS, Padi, Chennai 600 050, wherein selling sugarcane juice, cool drinks and fruit juice items therein till the Town Vending Committee is formed and decided on the petitioner's representation dated 18/2/2023 is considered, as per the provision of the Street Vendors (Protection of Livelihood Regulation) Act, 2014.

ORDER

This writ petition has been filed to forbear the respondents from interfering with the running of the petitioner's pushcart at MTH Road by side of Saravana Store main gate, opp. To Lukas TVS, Padi, Chennai 600 050.

2. It is the case of the petitioner that she is running a bunk shop for the past several years and earning a meagre sum for her livelihood. It is her further case that the officials of the respondents are frequently visiting the shop and threatening to remove the shop. Hence, the instant writ petition.

3. Mrs.P.T.Ramadevi, learned Standing Counsel takes notice for the respondents and on instruction submitted that the Vending Committee is yet to be constituted and they are awaiting orders from the Government.

4. Once the Vending Committee is formed, petitioner is directed to give a fresh representation and on such representation being given, the Vending Committee shall consider the representation of the petitioner, and

pass orders, on merits and in accordance with law, within a period of two months, thereafter. Till such time, the respondents shall not interfere with the running of the petitioner's bunk shop.

5. With the above direction, this writ petition is disposed of. No costs.
