The grievance ventilated by the Petitioner, who retired from service after working as Anganwadi Worker in Yerunthavadi North Anganvadi Center Kudavasal Taluk, Thiruvarur District, is that she has made a representation dated 26.10.2022 for payment of Rs. 37,748/- along with interest which had been deducted from her salary for the period from 01.08.2015 to 31.08.2018 towards contribution for General Provident Fund, but as it did not evoke any response, she has filed this Writ Petition.

4. Learned Government Advocate appearing for the First to Sixth Respondents, on instructions, states that after the filing of the Writ Petition, the Sixth Respondent by proceedings in Lr. R.C.No. 15089/D/2023 dated 14.03.2023 has made payment of Rs. 33,921/- to the Petitioner and its copy has been produced, the receipt of which is also acknowledged by the Learned Counsel for the Petitioner.

5. In such circumstances, nothing remains for consideration in the matter, but it would not preclude the Petitioner, if she still has any grievance, from working out her remedy before the proper forum in the manner recognized by law.
