The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the

event of the temple festival of Arulmigu Shri Sakthi Mariamman Thiru Kovil, vasugi Nagar, Komarapalayam, Namakkal District to be held on 02.03.2023 at 06.00 pm onwards, by considering the petitioner's representation dated 23.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of the temple festival of Arulmigu Shri Sakthi Mariamman Thiru Kovil, vasugi Nagar, Komarapalayam, Namakkal District to be held on 02.03.2023 at 06.00 p.m. onwards, the petitioner has sent a representation dated 23.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
