2. Directions are sought to remove the unauthorized construction of compound wall and gate by the sixth and seventh respondents in Plot Nos. 17 and 18.

3. We asked the learned counsel for the petitioner as to who are the owners of Plot Nos.17 and 18. The learned counsel for the petitioner replies that respondent No.6 is the owner of the said plots and respondent No.6 has carried out the construction of compound wall.

4. We fail to understand as to how the petitioner would be affected if the respondent No.6 carried out the construction of compound wall in his own plot. We are not going to entertain such petitions. No public cause is involved in the present matter.

The writ petition, as such, is dismissed. There will be no order as to costs.
