2. The matter is of the year 2018. The petitioner seeks a direction against the second respondent to take action pursuant to the enquiry report of respondents 5 and 6 for disconnection of electricity and upon theft of water.

3. Counter filed on behalf of the seventh respondent states that the Collector has not issued orders for disconnection.
