However, he was not issued with any order and once again, the third respondent called for an interview on 29.10.2012. Thereafter, the petitioner did not receive any order.

4. On written instruction, the learned Government Advocate appearing for the respondents submitted that the petitioner's age was barred and as such, he was not selected to the post of Office Assistant in the Veterinary Animal Husbandry Department.

5. In view of the above submission, this writ petition is devoid of merits and is liable to be dismissed. Accordingly, this Writ Petition stands dismissed. Consequently, connected miscellaneous petitions are closed. There shall be no order as to costs.
