3. It is seen that the petitioner has approached this Court without exhausting the alternate remedy available to him.

4. However, it is learnt from the statement made by the learned counsel for the petitioner that the petitioner has filed this writ petition without giving any representation to the government to review the order of the 1st respondent dated 25.06.2020.

5. In such a case, the petitioner is at liberty to make a representation to the government to review the order passed by the 1st respondent in his proceedings vide Na.Ka. 543/2020/Sa.Pa, dated 25.06.2020 with regard to the quantum of

In the event that the petitioner gives any representation to the Additional Chief Secretary to the Government, Department of Cooperation, Food, and Consumer Protection Department, Secretariat, Chennai 600 009, and receives it, the Additional Chief Secretary to the Government, Department of Cooperation, Food, and Consumer Protection Department, Secretariat, Chennai 600 009, shall consider and pass an appropriate order on merits within a period of six weeks from the date of receipt of a copy of this order.

6. with the above observation, this Writ petition is disposed. No costs.
