dispose the case within a period of four months from the date of receipt of a copy of this order. Further, the respondent is directed to pay a sum of Rs.8,000/- as interim maintenance to the respondent until modified by any Court of law and both the parties are directed to appear before the Sub Court, Kovilpatti, for mediation not less than three sittings. No costs.
